Location

The property is situated within Sale, a town within the Borough of Trafford and within the Greater Manchester Conurbation.

The Town is located approximately 2 miles South of Stretford, 2.5 miles North East of Altrincham and 5 miles South West of Manchester. Sale itself is situated on the A56, one of the arterial routes which provides direct access into Manchester City Centre from the South West.

The A56 also links Sale with Altrincham to the South West and Stretford to the North. Furthermore, the A56 also provides convenient access to Junction 7 of the M60 Manchester Orbital Motorway.
